Collection of fees policy



Introduction

Tuition fees: amounts that are directly related to the education of students .

Other fees: are school books, uniforms and transportation fees .

According to school fees, tuition and other fees together and which obliges school parents pay .

The collection of tuition fees

You must provide the possibility of payment of tuition fees in three installments equal at least to be able to parents.

Matters of school fees to cover during the school year, the school may meet the first installment during the month before the start of the school year. And pay the first installment in March for schools that begin year of the school in April, and in August for schools that begin the school year in September And that the school may retain a specified amount of tuition fees in the following case

If a student enrolled in the school for any length of the first week in the classroom, or did not attend School parent school in writing before the start of the actual study did not know well in advance .

Then the school has the right to retain the fees for registration or re-registration

If a student enrolled in the school for a week to three weeks in the classroom, entitled

For the school to keep the value of the entire month of tuition fees

If a student enrolled in the school for more than three weeks to a maximum of six weeks in Semester, the school has the right to retain the value of two months of tuition fees .

If a student enrolled in the school for more than six weeks in the classroom, the school has the right to retain the value of the full tuition fees for the semester

These cases apply to new students and students who have signed up after the start of the semester. Calculated public holidays and days of absence for a week. It should estimate the value of fees and one month of the value of total tuition fees divided by ten months. The guardian is entitled to recover textbooks and school uniforms for students full fees if not used after. The school transport fees should be returned following the same manner in which relive the tuition fees. And the school management to inform parents in writing these conditions when you register or re-register, and in perfect picture .through a written agreement between the parent and the school

Non-payment of school fees

No student may be separated from the school because of the delay in the payment of school fees, but the school may stop temporarily the student out of school for up to three days after his guardian three times alarm warning in writing a week at a time. It may also withhold the result of the student and to refrain from certificates of transition) or blocking the transfer student on electronic Student Information System Exchange (or refrain from re-registration of the student until the special fees settlement procedure, and may not be denied to any student from entering the last quarter or year exams or exam During the year because of the decision not to pay school fees. The schools should deal with non-payment of school fees and issues in a confidential manner in order to protect the student from embarrassment or to draw any unnecessary attention

Payment of installments of the ongoing school students

First installment: it begins with the collection of the first installment from the date of 06.20.2015 and until the date of 20/8 / 2015 rate (35%) and the obligation to pay when you do not have the right to replace the student's .school

The second installment: begins with the collection of the second installment in (the history of 11.15.2015 and until the date of 15.12.2015 by (35%

The third installment: begins with the collection of the third installment in the (history of 02.12.2016 and until the date of 15/3 / 2016 (30%

Enrolled students in kindergarten and twelfth and have no brothers begins the first installment from the date of 20.06.2015 and 20.08.2015 until the date of collection by 50% and the last installment in the 01/12/2016 and until the date of 02.11.2016

The agreed for the current school year, school fees and is considered the guardian binding for payment for the management of the school, according to previous dates

If no guardian obligation to pay all or some of the prescribed fees, after reminding him that it is entitled to the school administration to take all the legal procedures provided for in the list of special education, and to prevent .registration of the student in the next school year

Payment of installments for new students

First installment: it begins with the collection of the first installment from the date of 01.06.2015 and until the date of 19/6 / 2015 rate (35%) and the obligation to pay when you do not have the right to replace the student's school

Conditions to be met by the school include:
Schools are not allowed to charge parents for the whole year's fees in one payment, and must also ensure that:
a) The school fees should be collected at the beginning of each trimester/semester* or monthly
b) When charged, registration fees are deductible from the tuition fees. They must not be more than 5% of the annual tuition fee.
